(NYSE:BRO) (the "Company") today announced that it has entered into an accelerated share repurchase program (ASR) with JPMorgan Chase Bank, National Association, for up to \$75 million of the Company's common stock. The ASR is part of the Company's board-approved \$400 million share repurchase authorization announced on July 20, 2015.
